A Great Fun Match

Our annual Specialty Fun Match was held on June 22nd. This year we had help from the Mal club and from NorSled..... a great addition to the day! We had lots of entrants and lots of dogs, from the teeniest tiniest little red Siberian puppy (not my new puppy Jodee, who looked like an elephant compared to this puppy), to a ginormous, fluffy Sammy, who just came to visit and get petted. (Don't tell him I called him fluffy....I don't want him to get embarrassed.) In between we had pure bred Sibes and Sibe mixes, all full of energy and dying to examine (and eat) everything in the park, and gorgeous big Mals (who are pretty sure they are the rulers of the world). Just seeing the parade of dogs was worth it!

The day began with the Husky Charm School, taught by Nanette Morgan. This focused on how to work with your dog to elicit the behaviors you would like. The class was quite full and the dogs (and especially the owners) were doing better by the end of the class.

Then there was judging for best pure bred Siberians and Malamutes (separate classes), best Spay-Neuter for each, and best Sled Dogs. Our judges for these classes were Celine Tews and Bill Griffiths. There were a lot of dogs in these classes, so they were kept quite busy. The day started out pretty cool, but got hotter at midday, so by the time these classes were finished it was hot in the sun! We all got a lot of exercise running around the rings with our dogs. It was a challenge for those of us who don't usually show our dogs to get them to stand still when needed while in the ring and to get them to run around under control (the "under control" is the tricky part....they have no problem with the "running around"). It was very interesting to watch and compare the way the dogs moved and their builds, trying to see what the judges were looking for. Marilyn Lassagne agreed to judge our Best in Match

The last class of the day was judging for junior and adult handlers. This is where the people are judged, instead of the dogs. Marilyn Lassagne judged this class, and it was an opportunity for all of us to learn how we should show a dog. She explained the process and the reasons for doing it in certain ways, so it was a great learning experience.

We had lunch from Togo's, as usual. There were picnic tables in the shade so we got to sit and cool off while eating sandwiches, chips, and cookies.

For the shoppers among us, we had a great raffle and silent auction. Thanks to all of those who brought items to contribute to these events, and also who bought tickets and competed for silent auction items. We had some great things and people were very active in fighting for the items they wanted.

No event like this is successful without lots of help, so we want to thank all of you who helped with set up and take down, who participated in the show, who participated in our raffle (by forking over some dough!) and who made it such a successful day. Hope to see you all again!!

It is all so interesting, so many things to learn. I met a loud, sucky thing that makes a lot of noise and has a really long skinny snout. Some of the big dogs are scared of it, but I showed it who is boss!! I growled and barked at it and even pounced on it a time or two. Then it went away. I was very brave.

Mom tells them to be gentle cuz I'm little, but they kind of ignore her. So I just go under things. Besides, its fun to play with them. One of them looks a lot like me...red with blue eyes....and we play a lot. Her name is Frankee. She likes to gnaw on my neck. Ralfee, my big brother, likes to play tug of war with me...he holds one end of Mom's slipper while I hold the other, and then we just pull like crazy. Sometimes he pulls me, sometimes I pull him. I like to chew on Mom's slippers as well...she says they now have Puppy Pattern Baldness.

I discovered a really fun thing the other day. There is a big bowl of water on the floor in the kitchen. I can fit right in it!! All 4 paws!! Umunhum Carting and Camping

Through out the summer we cart with our dogs by moonlight. It is a fun time with our dogs getting exercise, learning to work with a team and as a team.

We meet around 5 pm on Saturday night and if the weather allows, we run the dogs between 7 and 9 pm. If it is warm we eat dinner first and then run them. They run from 1 mile to 7 miles, again it is based on the weather...the warmer it is the shorter we run. In the past 5 years of doing this event we have been unable to run 3 times. Dinner is a group effort.

Some people then camp in tents but most campout in their cars or beside them.

In the morning we rise with the sun and run the dogs again. We try different dogs in different positions and come back to a GREAT group breakfast and off the hill by 10 or 11 am.... You still have time to do things before the end of the weekend.

Most people go up for the whole event. SOMETIMES (not all the time) we have a couple that only come up for the evening part. This can only happen if we have at least two cars going down at the same time (one that has the responsibility of a key)

Tentative dates – They can always change because of heat, fire, dog shows and other events.

What you need to bring- your own drinks, sleeping bag, food for your dog and food for the group.

It is great fun and very relaxing. The views of Santa Cruz, Monterey Bay and Santa Clara County are wonderful both as the sun rises and the sun sets. Come and join us.



IMPORTANT NOTES FOR PARTICIPANTS IN THE TEMPERAMENT EVALUATION PROGRAM

- 1. The ATTS Temperament Evaluation measures the dog's strength of response to arrive at the temperament baseline.
- 2. Dogs of at least 18 months of age, either pure-bred or neutered or spayed mixed-breeds, are eligible to participate. Non-neutered and non-spayed mixed-breeds may also participate but will not receive a certificate or a Temperament Title.
- 3. Owners of eligible dogs, which pass the test requirements and are officially verified by ATTS, will be awarded an ATTS Temperament Title Certificate showing the dog's TT number with breed designation. This title may be listed after the dog's name.
- 4. The combined findings of the Chief Tester and the two Testers at the test are binding and final.
- 5. To promote uninfluenced, fair and uniform testing of all dogs, only one dog and one handler will be allowed in the test area during testing. Those who do not adhere to the A TTS Chief Tester's instructions may be denied participation without refund or may risk having their evaluation process cancelled without refund.
- 6. In compliance with changes in ATTS regulations, male dogs and bitches are no longer required to be tested separately, but will be followed by bitches in season. Bitches in season should not be in or near the testing area prior to being tested.
- 7. Taking of photos/videos is encouraged but must not interfere with the testing.
- 8. Smoking and consumption of alcoholic beverages are prohibited in the testing area.
- 9. Dogs deemed unacceptable for testing for reason of temperament (uncontrollable, overly aggressive, extremely fearful, etc.), health, poor appearance, handicap or advanced pregnancy may not participate.
- 10. A dog failing one or more of the ten subtests is considered as failing the evaluation. A subtest is failed when a dog shows unprovoked aggression, obvious avoidance, or panic without recovery; the test may be terminated immediately without refund. A dog may be retested after a five-month waiting period (full entry fee required).

I certify that I am the actual owner of this dog or that I am the duly authorized agent of the actual owner whose name I have entered on the reverse side of this form. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the American Temperament Test Society and to accept the rulings of this organization or those working for this organization, and on completion of the activities, will accept the conditions of those in connection with this organization. I (we) further agree that the ATTS officials conducting this Evaluation have the right to refuse this entry for cause which A TTS shall deem sufficient.

I (we) certify that this dog entered is not a hazard to persons or other dogs, and I (we) further agree to accept full and complete responsibility for the actions of my (our) dog during the activities of this Evaluation. I (we) agree to hold the American Temperament Test Society (A TTS), its officials, officers, directors, members, advisers, agents, test participants, etc., and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any and all claims for loss or injury which may be alleged to have been caused directly or indirectly to any person, property or thing by the act of this dog or any other dog(s) belonging to me, or which I have brought with me, while in or upon the test premises or grounds or near any entrance thereto, and I (we) shall personally assume all responsibility and liability for any such claim.

I (we) agree to hold the aforementioned parties harmless for any claims for loss or injury to this dog(s) by disappearance, theft, death, or otherwise and for any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, etc. be caused or alleged to be caused by the negligence of A TTS, the host organization, or any of the aforementioned parties or by the negligence of any other person or any other cause or causes.

I (we) further agree to hold this organization, its officials, agents, employees of the aforementioned parties, and anyone working in and/or for this organization, as well as those working with or for a local, independent club and their dogs participating in any and all activities in connection with this organization harmless from any claim for loss, theft, damage or injury caused or alleged to be caused by the negligence of the organization or any of the parties aforementioned, or by the negligence of any other person, cause or causes.
